MUSIC COMPOSITION RULES



All participants must also follow General Rules for Participation.

Description

A Music Composition entry may be for voice, instruments or a combination of voice(s) and instruments. Lyrics may or may not be included in vocal compositions. The composition is not to exceed 5 minutes. The entry must relate to the current Reflections® Program theme

The use of composition software is permitted. The recording submitted may capture performers in real-time or may make use of a sound library-generated performance of a score composed in its entirety by the student participant. Use of notation software for the purpose of creating scores and printed parts is permitted. Whether the score is handwritten or computer-generated, appropriate instrumentation and voicing are required for the performance.

The entry may not include commercially pre-programmed imported MIDI or other source files, or use algorithmic composition software. Students are not to borrow from copyrighted material. Entries are judged primarily on how well the student uses his or her artistic vision to portray the theme.

Presentation & Format

- The music composition should directly relate to the theme.
- Music recording must not exceed 5 minutes in length and 1GB (one gigabyte) in file size.
- Accepted files include: MP3, MP4, WMA, WAV, ACC, FLAC.
- Whether a student must submit musical notation is determined by the student's grade division:
- Primary (grades Prek-2) and Intermediate (grades 3-5) Grade Divisions do not require musical notation. Iconic notation ("made-up" notation) may be submitted.
 - Middle (grades 6-8) and High School (grades 9-12) Grade Divisions require notation, either traditional or tablature.
- Students with disabilities may dictate to another person who may write the notation.
- The composer is not required to perform his/her composition.
- A student's composed work may be performed by a group or may make use of a sound library generated performance of a score composed in its entirety by the student participant.

Tips for Audio Quality

- Do not place the recording device on top of an instrument(s) or speakers.
- Turn off all noise-making devices in the room (air conditioners, fans, telephones, etc.).
- Record a short test and listen to it. If needed, improve recording quality by changing the record volume or microphone location.
- Return to the beginning of the CD and record two seconds of silence; then start performing your composition. Finish with another two seconds of silence.

Instructions for Packaging and Submitting Entries

- Record performance on a CD (save as electronic file, not as CD/DVD movie).
- ♦ Label both CD and cover with name (First Initial and Last name, ie: J. Doe), title of your artwork, arts category, and grade division
- If music score/notation is required, submit on 8.5 x 11 paper. Put name (First initial and Last name) and page numer on back of pages. Example: J. Doe, Page 1 of 2; J. Doe Page 2 of 2, etc.
- ♦ Do not mount or bind the scores.
- Place CD and music score/notation in a 10" x 13" manila Envelope.
- Completely fill out the Student Entry Form including the specific information requested for the Music Composition category as well as the Artist Statement
- Insert:
 - SIGNED Student Entry Form
 - Artist Statement & Information Form
 - Consent Form if required (see form for instructions)
 Into a clear plastic sheet protector with Student Entry Form on top so student information can be clearly seen.
- Tape sheet protector to the manila Envelope.
- Submit envelope with your CD and music score/notation and student entry forms to your PTA Reflections Chair on the due date given for your school.
